- THE 2011-2012 TRIPLE THREAT DANCE & CHEER DANCE COMPANY TRYOUTS WILL BE HELD FOR GIRLS AND BOYS AGES 4-18.

THIS YEAR....

- SEPARATE COMPETITIVE BALLET & JAZZ CLASSES
 - NO SPECIFIC TEAM PLACEMENT
- IN ADDITION TO COMPANY TRYOUTS STUDENTS WILL BE INDIVIDUALLY SELECTED FOR EACH DANCE.
 - COMPETE AT 4 COMPETITIONS

SELECTION CRITERIA

- DANCERS WILL BE SELECTED BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE.
- DANCERS WILL COMPETE IN JAZZ, LYRICAL, MUSICAL THEATER, CHARACTER, ACROBATICS, AND CONTEMPORARY CATEGORIES.
- FOR THE 2011-2012 COMPETITIVE YEAR
 - YOUR CHILD MAY BE CHOSEN FOR 1-4 DANCES.
 - DANCERS WILL BE PLACED IN DANCES BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE.
- ALL DANCE DECISIONS AND INDIVIDUAL PLACEMENTS ARE LEFT TO THE CHOREOGRAPHER AND WILL BE FINAL.
- A COMPANY MEMBER ROSTER WILL BE POSTED ON THE STUDIO WEBSITE BY 4:00PM SATURDAY JUNE 4RD, 2011.
 - COMPANY MEMBER ROSTER WILL NOT BE POSTED IF ANY VEHICLE (WITH THE EXCEPTION OF STAFF) PARENTS, AND/OR CHILDREN ARE IN THE GYM PARKING LOT AND/OR ANY SURROUNDING PARKING LOT.

- FOR GIRLS AND BOYS AGES 8-12

 - 10:30-12:00PM TRYOUT
 - ALL GIRLS/BOYS (AGES 8-12) SHOULD BE PICKED UP FROM THE TRYOUT CLINIC AT 12:00PM.
- FOR GIRLS AND BOYS AGES 13-18
 - 1:00PM CLINIC CHECK IN
 - 1:00-2:30PM TRYOUT CLINIC
 - ALL GIRLS/BOYS (AGES 13-18) SHOULD BE PICKED UP FROM THE TRYOUT CLINIC AT 2:30PM.

- WHAT HAPPENS IF I CANNOT MAKE IT TO THE SCHEDULED CLINIC AT TRYOUT?
 - FOR NEW AND RETURNING MEMBERS: IF, FOR SOME REASON, YOU CANNOT MAKE IT TO YOUR SCHEDULED CLINIC AND TRYOUT, YOU MAY CONTACT MERANDA TO SCHEDULE A PRIVATE TRYOUT. YOU WILL, HOWEVER, THEN BE RESPONSIBLE FOR THE \$20.00 NON-DISCOUNTED TRYOUT FEE (+) AND ADDITIONAL \$20.00 PRIVATE TRYOUT FEE (\$40.00 TOTAL.)
 - TRYOUT INFORMATION
 - THE TRYOUT CLINIC WILL TAKE PLACE AT TRIPLE THREAT DANCE & CHEER IN A LAID BACK ATMOSPHERE.
 - THE CLINIC IS NOT DESIGNED TO BE DIFFICULT. IT IS DESIGNED TO TEACH BASIC DANCE FUNDAMENTALS AND TRYOUT MATERIAL THAT THE JUDGES WILL BE EVALUATING.
 - THE CLINIC IS DESIGNED TO HELP THOSE TRYING OUT FEEL COMFORTABLE.
 - WITH THE CLINIC MATERIAL WHEN TRYING OUT
 - WITH THE STUDIO SET-UP AND TRYOUT PROCEDURE

 - FOR SINGLE, DOUBLE, AND TRIPLE PIRQUETTES
 - FOR RIGHT, LEFT, AND ARABIAN LEAPS
 - FOR ILLUSIONS, AND MORE ADVANCE SKILLS FOR OLDER CHILDREN
- CAN PARENTS OBSERVE/VIDEO THE TRYOUT AND/OR TRYOUT CLINIC?
 - BOTH TRYOUTS AND TRYOUT CLINIC WILL BE CLOSED TO PARENT OBSERVATION;
 - CLINIC DRESS CODE:

 - AFTER COMPLETING ALL FORMS, REGISTERING, AND PAYING FOR THE 2009-2010 COMPANY TRYOUT, BOTH GIRL AND BOY PARTICIPANTS WILL BE ASSIGNED A NUMBER.  - \$15.00 IF CHOOSING TO REGISTER ON OR BEFORE THURSDAY JUNE 2ND, 2011
 - \$20.00 IF CHOOSING TO REGISTER DURING FINAL REGISTRATION ON FRIDAY JUNE 3RD, 2011.
 - \$40 IF PARTICIPATING IN A PRIVATE TRYOUT.

TRYOUT FEES ARE NON-REFUNDABLE

- ANNUAL REGISTRATION FEE (PAYABLE TO TTDC)
 - REQUIRED FOR ALL NEW AND RETURNING MEMBERS
 - \$20.00
- TUITION (PAYABLE TO TTDC)
 - MONTHLY TUITION PRICE INCLUDES ALL COMPETITION, CHOREOGRAPHY, MUSIC, AND COACHES FEES.(ADDITIONAL FEES WILL BE CHARGED FOR THOSE CHOOSING TO DO A SOLO OR DUO/TRIO AT COMPETITION.
 - DUE THE 1ST OF EVERY MONTH
 - A \$15 LATE FEE WILL BE APPLIED IF NOT PAID BY THE 5TH OF EVERY MONTH.
 - BASE(INCLUDES REQUIRED CLASSES) TUITION PER MONTH
 - * \$85.00
 - * INCLUDES A BALLET, JAZZ, AND TECHNIQUE CLASS
 - * ADD AN ADDITIONAL \$30.00 FOR EACH DANCE YOUR CHILD IS IN AT COMPETITIONS.

 - WITHOUT THIS INFORMATION, YOUR CHILD WILL BE INELIGIBLE TO COMPETE AS A TRIPLE THREAT COMPANY MEMBER
 - A CREDIT CARD AUTHORIZATION FOR IS ATTACHED TO THIS TRYOUT PACKET AND MUST BE COMPLETED/RETURNED UPON REGISTERING FOR TRYOUTS.
 - IF YOU CHOOSE NOT TO RELEASE YOUR CREDIT CARD INFORMATION TO TRIPLE THREAT DANCE AND CHEER, INC AND TRIPLE THREAT DANCEWEAR YOU MAY:

TRIPLE THREAT DANCE COMPANY COMMON QUESTIONS

- **WHEN DO COMPETITIONS TAKE PLACE?**
 - ON THE WEEKENDS ONE DAY COMPETITIONS ARE TYPICALLY ON SATURDAYS. TWO-DAY COMPETITIONS ARE SATURDAY AND SUNDAY. THREE-DAY COMPETITIONS ARE FRIDAY, SATURDAY, AND SUNDAY.
 - ALL COMPANY MEMBERS WILL COMPETE 5 TIMES THIS SEASON
 - THE TENTATIVE COMPETITION SCHEDULE WILL BE RELEASED IN JUNE.
 - WHEN DO WE RECEIVE OUR COSTUMES?
 - * AFTER MAKING THE TEAM
 - * WE WILL MEASURE ALL MEMBERS IN CLASS
 - * ALL COSTUMES WILL BE DONE NO LATER THAN NOVEMBER.
 - * HOW DO YOU SELECT YOUR COMPANY MEMBERS?
 - + BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE.
 - + WE SELECT TEAMS TO BE THE MOST COMPETITIVE IN EACH PARTICULAR DIVISION WE CHOOSE TO ENTER.
 - + IF I TRY OUT FOR THE DANCE COMPANY, AM I ALLOWED TO QUIT PRE-SEASON AND/OR MID/SEASON?

ABSOLUTELY NOT!!! IF YOU ARE CHOSEN TO BE ON ONE OF OUR COMPETITIVE COMPANIES, YOU ARE ALSO MAKING A 12 MONTH TIME AND FINANCIAL COMMITMENT. (JUNE 6TH, 2011-MAY 31ST, 2012) WE CANNOT, HOWEVER, FORCE YOU TO REMAIN ON THE COMPANY IF YOU ARE INSISTING ON QUITTING. IF YOU CHOOSE TO QUIT, YOU WILL STILL BE RESPONSIBLE FOR ALL REMAINING TUITION AND TRIPLE THREAT DANCEWEAR FEES FOR THE ENTIRE YEAR. (REFER TO MONEY MATTERS PAGE FOR ADDITIONAL INFORMATION.) THERE WILL BE NO REFUNDS GIVEN TO ANY CHILD AND/OR PARENT THAT QUILTS COMPANY OR IS DISMISSED FROM THE PROGRAM BY THE COACHING STAFF.

WHAT ARE THE DANCE COMPANY REQUIREMENTS?

COMPETITIVE DANCE IS THE EQUIVALENT OF A "TRAVEL" SOFTBALL/BASEBALL/SOCCER TEAM. 100% DEDICATION TO YOUR TEAM IS REQUIRED; THEREFORE, ALL PRACTICES (EVEN EXTRA PRACTICES,) ARE MANDATORY.

PRACTICE TIMES MAY BE CHANGED, ADDED, EXTENDED, AND/OR CANCELLED THROUGHOUT THE SEASON FOR VARIOUS REASONS. THERE WILL BE NO ADDITIONAL COSTS FOR EXTENDED/ADDED PRACTICES JUST AS THERE WILL BE NO DISCOUNTS FOR CANCELLED PRACTICES.

AN ABSENCE WILL ONLY BE EXCUSED FOR A DEATH IN THE FAMILY, SCHOOL FUNCTION THAT RESULTS IN A GRADE FOR A CLASS, PREVIOUSLY SCHEDULED SUMMER VACATIONS, AND CONTAGIOUS SICKNESS.

SUMMER VACATIONS ARE DEFINED AS “VACATIONS SCHEDULE FROM JUNE 6TH - AUGUST 1ST. AFTER AUGUST 1ST, AN UNEXCUSED ABSENCE COULD RESULT IN TERMINATION FROM THE DANCE COMPANY PROGRAM.

FOR SICKNESS TO BE EXCUSED, YOU MUST CONSULT WITH YOUR CHILD’S COACH FIRST. IF YOU ARE SICK, YET NOT CONTAGIOUS, YOU ARE STILL REQUIRED TO PRACTICE WITH YOUR TEAM. IF YOU CHOOSE NOT TO PRACTICE SICK, YOU MAY BE ASKED TO PROVIDE A DOCTOR’S EXCUSE AND/OR BE RELEASED FROM THE DANCE COMPANY PROGRAM.

YOU MUST CALL AHEAD IF YOU ARE GOING TO BE LATE TO ANY PRACTICE.

TARDINESS IS DEFINED AS “NOT BEING ON THE PRACTICE FLOOR, READY TO PRACTICE, WHEN PRACTICE BEGINS. THIS MEANS; PRACTICE CLOTHES AND SHOES ON, HAIR UP, SNACKS EATEN, DRINKS PUT AWAY, AND BATHROOM USED.

EXCESSIVE TARDIES AND ABSENCES COULD RESULT IN TERMINATION FROM THE DANCE COMPANY PROGRAM.

PRACTICES/COMPETITIONS ARE NEVER TO BE USED AS PUNISHMENT FOR YOUR CHILD’S ACTIONS OUTSIDE THE GYM.

CAN I BE A DANCE COMPANY MEMBER AND PARTICIPATE IN OTHER EXTRA CURRICULAR ACTIVITIES AS WELL?

ABSOLUTELY!!! WE ENCOURAGE EXTRA CURRICULAR ACTIVITIES; HOWEVER IF YOUR EXTRA CURRICULAR COACH/SPONSORS REFUSES TO WORK WITH OUR MANDATORY PRACTICES AND COMPETITIONS, YOU WILL THEN BE REQUIRED TO CHOOSE WHICH ACTIVITY YOU WISH TO CONTINUE.

DO I HAVE TO REPRESENT THE TRIPLE THREAT DANCE COMPANY PROGRAM?

ABSOLUTELY!!! YOUR BEHAVIOR AND MANNERS SHOULD REFLECT POSITIVELY OF THE DANCE COMPANY PROGRAM AT ALL TIMES. GOOD SPORTSMANSHIP, POLITE MANNERS, AND A KIND DISPOSITION ARE MANDATORY AT ALL PRACTICES AND COMPETITIONS. TRIPLE THREAT DANCE COMPANY PRIDES ITSELF ON SETTING/UPHOLDING A HIGH STANDARD OF BEHAVIOR. PARTICIPATION IN THE DANCE COMPANY PROGRAM IS A PRIVILEGE, NOT A RIGHT.

WHY DO SOME PARENTS FEEL THE NEED TO BAD MOUTH COACHES, KIDS, PARENTS, AND OTHER TEAMS?

WE HAVE NO IDEA

WHEN WILL I RECEIVE THE OFFICIAL DANCE COMPANY HANDBOOK AND CODE OF CONDUCT, AS WELL AS ADDITIONAL INFORMATION CONCERNING FINALIZED PRACTICE AND COMPETITION SCHEDULES, UNIFORMS, DRESS CODES, AND OTHER DANCE COMPANY EXPECTATIONS/GUIDELINES/RULES/AND POLICIES, ETC?

AFTER YOU MAKE THE TEAM

IN JUNE, THERE WILL BE A MANDATORY PARENTS MEETING FOR ALL NEW AND RETURNING MEMBERS.

MEETING DATE WILL BE POSTED ON THE GYM DOORS WEDNESDAY JUNE 4th, 2011 (WITH THE NEW COMPANY MEMBER ROSTER.)
