THIS YEAR WE WILL HAVE 2 LEVELS OF COMPETITIVE DANCE

**PRE-PROFESSIONAL-** THIS IS FOR DANCERS THAT ARE NEW TO COMPETITION, HAS 1-2 YEARS EXPERIENCE IN COMPETITIVE DANCE, OR DOESN'T WANT TO MAKE AS MUCH OF A TIME AND FINANCIAL COMMITMENT AS OUR PROFESSIONAL LEVEL. DANCERS ARE REQUIRED TO TAKE A BALLET, JAZZ, TECHNIQUE, AND THEIR SPECIFIC DANCE PRACTICE. IT IS OPTIONAL FOR THEM TO TAKE TUMBLING OR ACRO, BUT IS HIGHLY RECOMMENDED. PRE-PROFESSIONAL DANCERS MAY PARTICIPATE IN 1-3 GROUP DANCES DEPENDING ON PLACEMENT, THESE GROUPS ATTEND 1 CONVENTION, AND 4 LOCAL COMPETITIONS.

**PROFESSIONAL-** THIS IS FOR OUR MORE EXPERIENCED DANCERS THAT HAVE HAD AT LEAST 3 YEARS OF COMPETITIVE DANCE EXPERIENCE. THESE DANCERS WILL BE REQUIRED TO TAKE 2 BALLET, 1 JAZZ, 1 TECHNIQUE, 1 ADDITIONAL DANCE CLASS (JAZZ OR TAP), AND OPTIONAL FOR TUMBLING OR ACRO BUT IS HIGHLY RECOMMENDED. ALL DANCERS WILL PARTICIPATE IN 2-4 GROUP DANCES DEPENDING ON PLACEMENT, THESE GROUPS ATTEND 2 CONVENTIONS, 4 LOCAL COMPETITIONS, AND 1 COMPETITION THAT REQUIRES TRAVEL.

# SELECTION CRITERIA

DANCERS WILL BE SELECTED BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE.  
DANCERS WILL COMPETE IN JAZZ, LYRICAL, MUSICAL THEATER, CHARACTER, ACROBATICS, AND  
CONTEMPORARY CATEGORIES.

FOR THE 2017-2018 COMPETITIVE YEAR ALL DANCERS THAT ARE SELECTED FOR COMPANY WILL  
BE IN A LARGE GROUP

DANCERS WILL BE PLACED IN SMALL GROUPS BASED ON SKILL ABILITY, AGE, ATTITUDE,  
ATTENDANCE DURING THE PREVIOUS YEAR, AND PERSONAL DRIVE. (YOU MUST HAVE  
COMPETED WITH TTDC FOR ATLEAST 1 YEAR TO PARTICIPATE IN A SMALL GROUP)

ALL DANCE DECISIONS AND INDIVIDUAL PLACEMENTS ARE LEFT TO THE CHOREOGRAPHER AND  
WILL BE FINAL.

WHAT HAPPENS IF I CANNOT MAKE IT TO THE SCHEDULED CLINIC AT TRYOUT?

FOR NEW AND RETURNING MEMBERS: IF, FOR SOME REASON, YOU CANNOT MAKE IT TO YOUR SCHEDULED CLINIC AND TRYOUT, YOU MAY CONTACT MERANDA TO SCHEDULE A PRIVATE TRYOUT.

# **TRIPLE THREAT DANCE COMPANY COMMON QUESTIONS**

## **1. WHEN DO COMPETITIONS TAKE PLACE?**

- a. ON THE WEEKENDS ONE DAY COMPETITIONS ARE TYPICALLY ON SATURDAYS. TWO-DAY COMPETITIONS ARE SATURDAY AND SUNDAY. THREE-DAY COMPETITIONS ARE FRIDAY, SATURDAY, AND SUNDAY.
- b. ALL COMPANY MEMBERS WILL COMPETE ATLEAST 4 TIMES THIS SEASON
- c. THE TENTATIVE COMPETITION SCHEDULE WILL BE RELEASED AT THE PARENT MEETING

## **. 2. WHEN DO WE RECEIVE OR COSTUMES?**

- a. AFTER MAKING THE TEAM
- b. WE WILL MEASURE ALL MEMBERS IN CLASS
- c. ALL COSTUMES WILL BE DONE NO LATER THAN FEBRUARY.

## **3. HOW DO YOU SELECT YOUR COMPANY MEMBERS?**

- a. BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE.
- b. WE SELECT TEAMS TO BE THE MOST COMPETITIVE IN EACH PARTICULAR DIVISION WE CHOOSE TO ENTER.

## **4. IF I TRY OUT FOR THE DANCE COMPANY, AM I ALLOWED TO QUIT PRE- SEASON AND/OR MID/SEASON?**

- a. ABSOLUTELY NOT!!! IF YOU ARE CHOSEN TO BE ON ONE OF OUR COMPETITIVE COMPANY, YOU ARE ALSO MAKING A 12 MONTH TIME AND FINANCIAL COMMITMENT. (JUNE 5TH, 2017- JUNE 31ST 2018)
- b. WE CANNOT, HOWEVER, FORCE YOU TO REMAIN ON THE COMPANY IF YOU ARE INSISTING ON QUITTING. IF YOU CHOOSE TO QUIT, YOU WILL STILL BE RESPONSIBLE FOR ALL REMAINING TUITION AND TRIPLE THREAT DANCEWEAR FEES FOR THE ENTIRE YEAR. (REFER TO MONEY MATTERS PAGE FOR ADDITIONAL INFORMATION.)

- c. THERE WILL BE NO REFUNDS GIVEN TO ANY CHILD AND/OR PARENT THAT QUILTS COMPANY OR IS DISMISSED FROM THE PROGRAM BY THE COACHING STAFF.

#### 5. WHAT ARE THE DANCE COMPANY REQUIREMENTS?

- a. COMPETITIVE DANCE IS THE EQUIVALENT OF A "TRAVEL" SOFTBALL/BASEBALL/SOCCER TEAM. 100%DEDICATION TO YOUR TEAM IS REQUIRED; THEREFORE, ALL PRACTICES (EVEN EXTRA PRACTICES,) ARE MANDATORY
- b. PRACTICE TIMES MAY BE CHANGED, ADDED, EXTENDED, AND/OR CANCELLED THROUGHOUT THE SEASON FOR VARIOUS REASONS. THERE WILL BE NO ADDITIONAL COSTS FOR EXTENDED/ADDED PRACTICES JUST AS THERE WILL BE NO DISCOUNTS FOR CANCELLED PRACTICES.
- c. AN ABSENCE WILL ONLY BE EXCUSED FOR A DEATH IN THE FAMILY, SCHOOL FUNCTION THAT RESULTS IN A GRADE FOR A CLASS, PREVIOUSLY SCHEDULED SUMMER VACATIONS, AND CONTAGIOUS SICKNESS.
- d. SUMMER VACATIONS ARE DEFINED AS "VACATIONS SCHEDULE FROM JUNE 5TH - AUGUST 10TH. AFTER AUGUST 10TH, AN UNEXCUSED ABSENCE COULD RESULT IN TERMINATION FROM THE DANCE COMPANY PROGRAM.
