THE 2023-2024 TRIPLE THREAT DANCE COMPANY TRYOUTS WILL BE HELD FOR GIRLS AND BOYS AGES 6-18.

ALL DANCERS WILL PARTICIPATE IN 1-4 GROUP DANCES DEPENDING ON PLACEMENT, THESE GROUPS ATTEND 1-2 CONVENTIONS, AND 4 COMPETITIONS THAT REQUIRE TRAVEL. FIRST YEAR DANCERS WILL BE PLACED IN PRODUCTION AND A LARGE GROUP.

### **SELECTION CRITERIA**

DANCERS WILL BE SELECTED BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE. DANCERS WILL COMPETE IN JAZZ, LYRICAL, MUSICAL THEATER, CHARACTER, ACROBATICS, AND CONTEMPORARY CATEGORIES.

FOR THE 2023-2024 COMPETITIVE YEAR ALL DANCERS THAT ARE SELECTED FOR COMPANY WILL BE IN LINE AND A LARGE GROUP. LARGE GROUPS ARE BASED MAINLY OFF OF AGE.

DANCERS WILL BE PLACED IN SMALL GROUPS BASED ON SKILL, ABILITY, AGE, ATTITUDE, ATTENDANCE DURING THE PREVIOUS YEAR, AND PERSONAL DRIVE. (YOU MUST HAVE COMPETED WITH TTDC FOR ATLEAST 1 YEAR TO PARTICIPATE IN A SMALL GROUP) ALL DANCE DECISIONS AND INDIVIDUAL PLACEMENTS ARE LEFT TO THE TRIPLE THREAT COMPANY STAFF AND WILL BE FINAL.

CHECK-IN WILL START 15 MINTUES BEFORE TRY OUT TIME. CHECK IN WILL CLOSE PROMPTLY AT THE START OF YOUR SELECTED TRYOUT TIME/SESSION. LATE COMERS WILL NOT BE PERMITTED INTO TRYOUTS.

*WHAT HAPPENS IF I CANNOT MAKE IT TO THE SCHEDULED CLINIC AT TRYOUT?*

FOR NEW AND RETURNING MEMBERS: IF, FOR SOME REASON, YOU CANNOT MAKE IT TO YOUR SCHEDULED CLINIC AND TRYOUT, YOU MAY CONTACT ALANA TO SCHEDULE A PRIVATE TRYOUT. YOU WILL, HOWEVER, THEN BE RESPONSIBLE FOR THE \$25.00 NON- DISCOUNTED TRYOUT FEE (+) AND ADDITIONAL \$25.00 PRIVATE TRYOUT FEE (\$50.00 TOTAL.)

TRYOUT CLINIC WILL TAKE PLACE AT TRIPLE THREAT DANCE COLLECTIVE IN A LAID BACK ATMOSPHERE. THE CLINIC IS NOT DESIGNED TO BE DIFFICULT. IT IS DESIGNED TO TEACH BASIC DANCE FUNDAMENTALS AND TRYOUT MATERIAL THAT THE JUDGES WILL BE EVALUATING. THE CLINIC IS DESIGNED TO HELP THOSE TRYING OUT FEEL COMFORTABLE WITH THE CLINIC MATERIAL WHEN TRYING OUT WITH THE STUDIO SET- UP, AND TRYOUT PROCEDURE WITH THE OTHER CHILDREN AND WITH THEIR FUTURE INSTRUCTORS. ALL CLINIC MATERIAL WILL BE TAUGHT BY ONE (OR MORE) OF THE 2023-2024 COMPANY INSTRUCTORS.

RIGHT, LEFT, AND LEAP IN 2ND

RIGHT, LEFT, AND MIDDLE SPLIT

ILLUSION

4 TURNS IN SECOND

DANCE TAUGHT AT CLINIC

MINIMAL REQUIRED SKILLS PER LEVEL

LEVEL 2 – CLEAN SINGLE PIROUETTE, RIGHT, AND LEFT LEG LEAP

LEVEL 3 – CLEAN SINGLE PIROUETTE, RIGHT, LEFT, AND MIDDLE LEAP

LEVEL 4- CLEAN DOUBLE PIROUETTE, RIGHT, LEFT, AND MIDDLE LEAP, ILLUSION

LEVEL 5 – CLEAN TRIPLE PIROUETTE, R/L/M LEAP, 4 TURNS IN SECOND INTO DOUBLE

FALL PRACTICE SCHEDULE AUGUST 7<sup>TH</sup> 2023- MAY 31<sup>ST</sup> 2024 - REQUIRED

A SPECIAL PRACTICE SCHEDULE WILL BE GIVEN FOR CHOREOGRAPHY WEEK. IF CHOOSING TO TRYOUT FOR THE 2023-2024 DANCE COMPANY YOU MUST BE ABLE TO ATTEND CHOREOGRAPHY WEEKS. WE CANNOT WORK CHOREOGRAPHY AROUND MULTIPLE VACATIONS AND CONFLICTS. WE HAVE GUEST CHOREOGRAPHERS SCHEDULED MONTHS PRIOR.

DURING SUMMER PRACTICE WEEKS, WE ATTEMPT TO BE EXTREMELY FLEXIBLE WITH FAMILIES VACATION SCHEDULES: HOWEVER, COMPANY MEMBERS ARE EXPECTED TO ATTEND ALL SUMMER CLASSES AND CAMPS. IF YOU ALREADY HAVE FAMILY AND/OR ACADEMIC PLANS SCHEDULED FOR THESE WEEKS, YOU SHOULD REARRANGE YOUR SCHEDULE NOW. IF YOU CANNOT REARRANGE YOUR SCHEDULE FOR THESE WEEKS, YOU MUST NOTIFY ALANA BEFORE TRYOUTS. FAILURE TO NOTIFY MAY RESULT IN YOUR CHILD'S DISMISSAL FROM THE TRIPLE THREAT DANCE COMPANY FOR THE 2023-2024 COMPETITIVE YEAR.

EXACT PRACTICE TIMES FOR CHOREOGRAPHY WEEK WILL BE POSTED BY THE FIRST WEEK OF JULY.

\*ATTENDANCE POLICY – DANCERS ARE ALLOWED 5 UNEXCUSED ABSENCES IN THEIR COMPANY REHEARSALS, AFTER 5 THEY WILL BE PLACED ON A PERFORMANCE PROBATION AND MAY BE REMOVED FROM GROUP ROUTINES, AND BECOME INELIGIBLE FOR ANY SOLO, DUOS, OR TRIOS.

**ALL DANCERS PLACED IN LEVEL 4 OR ABOVE WILL BE REQUIRED TO TAKE 1 ADDITIONAL DANCE CLASS PER WEEK.**

## **MONEY MATTERS**

THE COSTS INVOLVED DURING THE 2023-2024 COMPETITIVE SEASON (FOR ALL COMPANY MEMBERS) ARE AS FOLLOWS:

-TRYOUT FEE (PAYABLE TO TTDC) - \$25.00

-IF PARTICIPATING IN A PRIVATE TRYOUT - \$50.00 TRYOUT FEES ARE NON-REFUNDABLE

-ANNUAL REGISTRATION FEE (PAYABLE TO TTDC) - \$30 REQUIRED FOR ALL NEW AND RETURNING MEMBERS

-TUITION (PAYABLE TO TTDC) - MONTHLY TUITION PRICE INCLUDES ALL COMPETITION CLASSES AND IS DUE THE 1ST OF EVERY MONTH - A \$15 LATE FEE WILL BE APPLIED IF YOUR CARD ON FILE IS DECLINED EVERY MONTH. BASE (INCLUDES REQUIRED CLASSES) TUITION PER MONTH \$150.00 PER MONTH FOR DANCERS IN LINE AND 1 LARGE GROUP AND AN ADDITIONAL \$20 PER MONTH FOR EACH ADDITIONAL GROUP.

*\*TUITION INCLUDES A BALLET CLASS, JAZZ CLASS, TECHNIQUE CLASS, TEAM PRACTICES FOR LINE AND LARGE GROUP. THIS ALSO INCLUDES AN OPTIONAL TUMBLING OR ACRO CLASS. THIS DOES NOT INCLUDE YOUR COMPETITION FEES FOR EACH DANCE, CONVENTION FEE, CAMP FEE, OR CHOREOGRAPHY FEE.*

### **TUITION BREAKDOWN**

ADDITIONAL CLASSES -  $\$20/4 \text{ WEEKS} = \underline{\$5 \text{ PER CLASS PER WEEK}}$

\$50.00 SIBLING DISCOUNT FOR EACH TUITION PAYMENT.

OPTIONAL ADDITIONAL CLASSES ARE \$20.00/MONTH.

ADDITIONAL DANCE CLASSES ARE CONSIDERED TUITION PAYMENTS. THE \$20 FEE SHOULD BE MADE PAYABLE TO TTDC, AND ADDED TO YOUR REGULAR TUITION PAYMENT. ALL ADDITIONAL TUITION FEES WILL ALWAYS BE DUE ON THE SAME DATE AS YOUR REGULAR TUITION PAYMENT. SEE BREAKDOWN OF ALL TUITION PAYMENTS ON ATTACHED PAYMENT SCHEDULE.

ALL COMPETITION FEES ARE PAYABLE BY CASH, CHECK, ZELLE, OR VENMO. IF PAYING BY VENMO, YOU WILL NEED TO INCLUDE A 2% PROCESSING FEE TO YOUR PAYMENT. NO CREDIT OR DEBIT CARD PAYMENTS WILL BE ACCEPTED FOR THESE FEES.

ALL ADDITIONAL FEES SUCH AS; COSTUMES, PRACTICE WEAR, BAG, WARM-UP, TIGHTS, SHOES, AND TEAM T-SHIRTS WILL BE ORDERED THROUGH TRIPLE THREAT DANCEWEAR AND ARE PAYABLE BY CASH, CHECK, ZELLE, OR VENMO (+2%). SEE BREAKDOWN OF TRIPLE THREAT DANCEWEAR PAYMENTS ON ATTACHED PAYMENT SCHEDULE.

ALL DANCERS ARE REQUIRED TO PURCHASE A TRIPLE THREAT WARM UP JACKET FOR USE AT COMPETITION, PERFORMANCES, AND OUTINGS. ESTIMATED COST IS \$125, AND WILL BE MADE PAYABLE TO TTDC. THE FINAL COST WILL BE CALCULATED AND DUE BY NOVEMBER 1<sup>ST</sup> 2023.

\*ALL FEES OTHER THAN YOUR MONTHLY TUITION, TO INCLUDE: CONVENTION, COMPETITION, COSTUME, AND WARM-UP FEES ARE PAID TO TTDC, AND ARE THEN PAID TO THE RESPECTIVE COMPANIES. TRIPLE THREAT DOES NOT KEEP THESE FEES, AND THEREFORE CANNOT FORGO CHARGING PROCESSING FEES, OR LATE FEES FOR LATE PAYMENTS. WE APPRECIATE YOUR UNDERSTANDING.

A CREDIT CARD AUTHORIZATION FORM IS ATTACHED TO THIS TRYOUT PACKET AND MUST BE COMPLETED/RETURNED UPON REGISTERING FOR TRYOUTS. IF YOU CHOOSE NOT TO RELEASE YOUR CREDIT CARD INFORMATION TO TRIPLE THREAT DANCE AND CHEER, INC AND TRIPLE THREAT DANCEWEAR YOU MAY: PAY BOTH YOUR YEARLY TUITION AND TRIPLE THREAT DANCEWEAR FEES IN FULL (WITH ONE SINGLE PAYMENT) OR PAY BOTH YOUR YEARLY TUITION AND TRIPLE THREAT DANCEWEAR FEES IN FULL (WITH TWO SEPARATE PAYMENTS.) FIRST PAYMENT DUE JULY 1ST FINAL PAYMENT DUE SEPTEMBER 1<sup>ST</sup>.

ALL TUITION FEE PAYMENTS WILL AUTOMATICALLY BE CHARGED TO THE CREDIT CARD ON FILE AT TRIPLE THREAT DANCE COLLECTIVE.

IF DISMISSED FROM COMPANY OR A DANCE AND/OR CHOOSING TO QUIT (FOR ANY REASON) YOU WILL BE HELD RESPONSIBLE FOR ALL REMAINING TUITION AND DANCEWEAR FEES FOR THE 2023-2024 COMPETITIVE YEAR (JUNE 2023- JUNE 2024)

IF DISMISSED FROM COMPANY AND/OR CHOOSING TO QUIT A TEAM (FOR ANY REASON) TRIPLE THREAT DANCE COLLECTIVE RESERVES THE RIGHT TO CHARGE ALL REMAINING BALANCES TO THE CARD ON FILE ON THE SAME DAY YOU ARE RELEASED AND/OR QUIT A TEAM. WE ARE ALSO INCLUDING A REQUEST FORM FOR EACH SOLO/DUO/TRIO THAT WILL NEED TO BE COMPLETED AND TURNED INTO ALANA BY JUNE 26<sup>TH</sup> IN ORDER TO HAVE YOUR REQUEST CONSIDERED AND APPROVED BY OUR COMPETITIVE INSTRUCTORS. **DANCERS IN LEVEL 2, 3, AND 4 WILL BE REQUIRED TO PARTICIPATE IN SMALL GROUPS BEFORE BEING APPROVED FOR ANY SOLOS/DUOS/TRIOS.**

**IF A DANCER HAS A LIMIT OF 5 OR LESS DANCES, GROUP DANCES WILL BE ASSIGNED BEFORE ANY SOLOS/DUOS/TRIOS.**

PLEASE SEE ATTACHED CONTRACT AND REQUEST FORM, AND **READ THOROUGHLY** BEFORE COMPLETING AND TURNING IN.

ADDITIONAL SOLOS, DUO/TRIOS ARE TO BE PAID DIRECTLY TO YOUR CHOREOGRAPHER AND YOU MUST PRACTICE FOR ATLEAST 30 MINUTES PER WEEK. IF A SOLOIST OR DUO/TRIO DOES NOT SET UP A SCHEDULED WEEKLY PRACTICE YOU WILL NOT BE ABLE TO COMPETE WITH THAT SOLO OR DUO/TRIO. IF A PRACTICE IS MISSED THE TWO WEEKS BEFORE A COMPETITION, THE DANCER MAY NOT BE ALLOWED TO COMPETE THEIR SOLO AT THAT COMPETITION.

ALL PAYMENTS FOR SOLO OR DUO/TRIO PRACTICES MUST BE PAID BEFORE THE PRIVATE MAY START! IF YOU MISS A SCHEDULED PRIVATE WITHOUT 24 HOUR NOTICE YOU WILL STILL BE RESPONSIBLE TO PAY FOR THAT PRIVATE.

IF THESE RULES ARE NOT FOLLOWED BY DANCERS OR THEIR PARENTS, THIS WILL RESULT IN DISMISSAL FROM THE COMPANY AND INELIGIBILITY TO AUDITION IN THE FUTURE. WHEN BECOMING A PART OF A TEAM THERE ARE EXPECTATIONS PUT IN PLACE TO MAINTAIN AN ORGANIZED AND FAIR ENVIRONMENT FOR ALL INVOLVED. IF YOU WILL BE CHOOSING WHAT RULES YOU WOULD LIKE TO FOLLOW YOU WILL NO LONGER BE A PART OF THE TRIPLE THREAT DANCE COMPANY. **PLEASE INITIAL EACH LINE.**

\_\_\_ MY DANCER WILL ATTEND ALL REQUIRED CORE CLASSES AND REHEARSALS THROUGHOUT THE SEASON, UNLESS THEY ARE SICK OR WE HAVE AN EXCUSED ABSENCE.

\_\_\_ MY DANCER WILL WEAR ALL REQUIRED PRACTICE WEAR TO THEIR CLASSES.

\_\_\_ MY DANCER WILL WEAR ALL REQUIRED COSTUMING, HAIR, AND MAKEUP TO PERFORMANCES AND COMPETITIONS.

\_\_\_ MY DANCER WILL ATTEND ALL MANDATORY SESSIONS AND AWARDS AT ALL COMPETITIONS.

\_\_\_ MY DANCER WILL WEAR THEIR WARM UP JACKET TO ALL COMPETITIONS AND AWARDS CEREMONIES.

\_\_\_ I WILL NOT QUESTION OR BADMOUTH MY CHILD'S INSTRUCTOR'S DECISIONS. THIS INCLUDES LESSONS PLANS, FORMATIONS, CHOREOGRAPHY, CHANGES IN CHOREOGRAPHY, PLACEMENT, ETC.

\_\_\_ MY DANCER WILL WEAR THE REQUIRED SHOES TO THEIR CLASSES. (SHOES MAKE A VERY BIG DIFFERENCE IN THEIR TRAINING)

\_\_\_ I WILL BRING ANY COMPLAINT OR ISSUE TO THE DIRECTOR OF THE STUDIO AND WILL NOT SIT IN THE WAITING ROOM COMPLAINING WITH OTHER PARENTS, AS NO ISSUE CAN BE FIXED THIS WAY.

\_\_\_ **24 HOUR RULE:** I WILL WAIT A PERIOD OF 24 HOURS BEFORE SUBMITTING A COMPLAINT TO THE DIRECTOR IN ORDER TO MAINTAIN A LEVEL HEAD AND PERSPECTIVE ON A SITUATION. \*WE KNOW THAT THERE ARE HIGH EMOTIONS INVOLVED WHEN DEALING WITH PEOPLE'S CHILDREN, AND IT IS EVERYONE'S FIRST REACTION TO PROTECT AND DEFEND THEIR CHILD. WE ASK THAT PARENTS TAKE A BREATH AND TRY TO THINK OF THE OTHER SIDE OF THINGS BEFORE POINTING FINGERS AND GETTING ANGRY. WE PROMISE THAT WE LOVE ALL OF YOUR CHILDREN THE SAME, AND BENEFIT NOTHING BY HOLDING BACK A STUDENT OR BERATING THEM. THIS IS NOT THE TRIPLE THREAT DANCE COMPANY'S GOAL OR PHILOSOPHY, SO WE ASK THAT YOU PLEASE REMEMBER THAT WHEN ISSUES ARISE.\*

### **1. WHEN DO COMPETITIONS TAKE PLACE?**

\_\_\_a. ON THE WEEKENDS. ONE DAY COMPETITIONS ARE TYPICALLY ON SATURDAYS. TWO-DAY COMPETITIONS ARE SATURDAY AND SUNDAY. THREE-DAY COMPETITIONS ARE FRIDAY, SATURDAY, AND SUNDAY.

\_\_\_b. ALL COMPANY MEMBERS WILL COMPETE ATLEAST 4 TIMES THIS SEASON

\_\_\_c. THE TENTATIVE COMPETITION SCHEDULE WILL BE RELEASED AT THE PARENT MEETING.

\_\_\_d. DANCERS ARE REQUIRED TO BE PRESENT FOR ALL ARRIVAL, WARMUP, PERFORMANCE, AND AWARD TIMES. DANCERS THAT DO NOT ATTEND ALL REQUIRED AWARDS, OR DO NOT ARRIVE AT THE REQUIRED TIME WILL BE REVIEWED FOR REMOVAL FROM GROUP DANCES.

### **2. WHEN DO WE RECEIVE OUR COSTUMES?**

\_\_\_a. WE WILL MEASURE ALL MEMBERS IN CLASS

\_\_\_b. ALL COSTUMES WILL BE DONE NO LATER THAN FEBRUARY.

### **3. HOW DO YOU SELECT YOUR COMPANY MEMBERS?**

\_\_\_a. BASED ON SKILL ABILITY, AGE, ATTITUDE, AND PERSONAL DRIVE.

\_\_\_b. WE SELECT TEAMS TO BE THE MOST COMPETITIVE IN EACH PARTICULAR DIVISION WE CHOOSE TO ENTER.

### **4. IF I TRY OUT FOR THE DANCE COMPANY, AM I ALLOWED TO QUIT PRE- SEASON AND/OR MID/SEASON?**

\_\_\_a. ABSOLUTELY NOT! IF YOU ARE CHOSEN TO BE ON ONE OF OUR COMPETITIVE COMPANY, YOU ARE ALSO MAKING A 12 MONTH TIME AND FINANCIAL COMMITMENT.

\_\_\_b. WE CANNOT, HOWEVER, FORCE YOU TO REMAIN ON THE COMPANY IF YOU ARE INSISTING ON QUITTING. IF YOU CHOOSE TO QUIT, YOU WILL STILL BE RESPONSIBLE FOR ALL REMAINING TUITION FOR THE ENTIRE YEAR, AS WELL AS RECHOREOGRAPHY FEES OF \$50 PER DANCE YOU WERE IN. (REFER TO MONEY MATTERS PAGE FOR ADDITIONAL INFORMATION.)

\_\_\_c. THERE WILL BE NO REFUNDS GIVEN TO ANY CHILD AND/OR PARENT THAT QUILTS COMPANY OR IS DISMISSED FROM THE PROGRAM BY THE COACHING STAFF.

### **5. WHAT ARE THE DANCE COMPANY REQUIREMENTS?**

\_\_\_a. COMPETITIVE DANCE IS THE EQUIVALENT OF A “TRAVEL” SOFTBALL/BASEBALL/SOCCER TEAM. 100% DEDICATION TO YOUR TEAM IS REQUIRED; THEREFORE, ALL PRACTICES ARE MANDATORY

\_\_\_b. PRACTICE TIMES MAY BE CHANGED, ADDED, EXTENDED, AND/OR CANCELLED THROUGHOUT THE SEASON FOR VARIOUS REASONS. THERE WILL BE NO ADDITIONAL COSTS FOR EXTENDED/ADDED PRACTICES JUST AS THERE WILL BE NO DISCOUNTS FOR CANCELLED PRACTICES.

\_\_\_c. DANCERS ON THE COMPANY TEAM WILL ONLY BE ALLOWED 5 UNEXCUSED ABSENCES FOR THE 2023-2024 SEASON. AFTER 5 UNEXCUSED ABSENCES THE DANCER MAY BE PLACED ON A PERFORMANCE PROBATION OR DISMISSED FROM THE COMPANY. ABSENCES NOT ONLY HURT YOUR CHILD BY LIMITING THEIR PROGRESS BUT ALSO THE PROGRESS OF THEIR ENTIRE TEAM. AN ABSENCE WILL ONLY BE EXCUSED FOR A DEATH IN THE FAMILY, SCHOOL FUNCTION THAT RESULTS IN A GRADE FOR A CLASS, PREVIOUSLY SCHEDULED SUMMER VACATIONS, AND CONTAGIOUS SICKNESS.

\_\_\_d. FOR SICKNESS TO BE EXCUSED, YOU MUST CONSULT WITH YOUR CHILD’S COACH FIRST. IF YOU ARE SICK, YET NOT CONTAGIOUS, YOU ARE STILL REQUIRED TO OBSERVE PRACTICE WITH YOUR TEAM.

IF YOU CHOOSE NOT TO PRACTICE SICK, YOU MAY BE ASKED TO PROVIDE A DOCTOR'S EXCUSE AND/OR BE RELEASED FROM THE DANCE COMPANY PROGRAM.

\_\_\_e. YOU MUST CALL AHEAD IF YOU ARE GOING TO BE LATE TO ANY PRACTICE.

\_\_\_f. TARDINESS IS DEFINED AS "NOT BEING ON THE PRACTICE FLOOR, READY TO PRACTICE, WHEN PRACTICE BEGINS. THIS MEANS; PRACTICE CLOTHES AND SHOES ON, HAIR UP, SNACKS EATEN, DRINKS PUT AWAY, AND BATHROOM USED. THERE ARE RULES SET IN PLACE BY OUR INSTRUCTORS THAT WILL BE OUTLINED TO ALL COMPANY MEMBERS REGARDING BEING LATE TO ANY CLASSES.

\_\_\_h. EXCESSIVE TARDIES AND ABSENCES COULD RESULT IN TERMINATION FROM THE DANCE COMPANY PROGRAM.

\_\_\_i. PRACTICES/COMPETITIONS ARE NEVER TO BE USED AS PUNISHMENT FOR YOUR CHILD'S ACTIONS OUTSIDE THE GYM.

\_\_\_j. **IF A PRACTICE IS MISSED TWO WEEKS BEFORE A COMPETITION THAT DANCER MAY BE REMOVED FROM THEIR GROUP DANCES AND NOT ABLE TO COMPETE AT THAT COMPETITION.**

## **6. HOW WILL I KEEP UP WITH HOMEWORK OR OTHER ACTIVITIES?**

\_\_\_a. BEING A MEMBER OF THE TRIPLE THREAT COMPANY COMES WITH MUCH RESPONSIBILITY. DANCERS ARE NOT ONLY TRAINED IN DANCE AND PERFORMANCE BUT ALSO PUT TO THE TEST WITH THEIR TIME MANAGEMENT SKILLS.

\_\_\_b. COMPANY MEMBERS ARE EXPECTED TO BE AWARE OF, AND KEEP UP WITH THEIR ACADEMIC RESPONSIBILITIES.

\_\_\_c. DANCERS SHOULD NOT EXCESSIVELY MISS CLASSES FOR SCHOOL WORK, PROJECTS, OR OTHER RESPONSIBILITIES DUE TO LACK OF TIME MANAGEMENT. IF A DANCER HAS AN EXCESS OF SCHOOL WORK THEY MAY BE EXCUSED FOR PART OF THEIR REQUIRED CLASSES ON A GIVEN DAY TO CATCH UP, BUT THEY MAY NOT MISS ANY REQUIRED TEAM PRACTICES OR WHOLE DAYS OF DANCE.

\_\_\_d. IT IS THE DANCER'S RESPONSIBILITY TO COMPLETE THEIR SCHOOL WORK IN A TIMELY MANNER, IN THE TIMES THEY ARE NOT COMMITTED TO THEIR TRIPLE THREAT DANCE COMPANY.

## **7. CAN I BE A DANCE COMPANY MEMBER AND PARTICIPATE IN OTHER EXTRA CURRICULAR ACTIVITIES AS WELL?**

\_\_\_a. ABSOLUTELY! WE ENCOURAGE EXTRA CURRICULAR ACTIVITIES; HOWEVER IF YOUR EXTRA CURRICULAR COACH/SPONSORS REFUSES TO WORK WITH OUR MANDATORY REQUIREMENTS YOU WILL THEN BE REQUIRED TO CHOOSE WHICH ACTIVITY YOU WISH TO CONTINUE.

\_\_\_b. ABSENCES WILL ONLY BE EXCUSED FOR THE TIMES THEY ARE REQUIRED TO ATTEND SPORTING EVENTS ETC. IF A DANCER IS NOT REQUIRED TO REMAIN AT A SPORTING EVENT AFTER THEIR PERFORMANCE, OR THEY DO NOT ARRIVE TO THEIR REQUIRED CLASSES AFTER A SPORTING EVENT, THIS WILL RESULT IN AN UNEXCUSED ABSENCE AND CONDITIONING. TRAVEL TIMES TO AND FROM THE SCHOOLS FOR SAID EVENTS WILL BE TAKEN INTO CONSIDERATION, HOWEVER WE EXPECT DANCERS AND PARENTS TO ARRIVE IN A TIMELY MANNER AFTER THE TRIPLE THREAT COACHES HAVE ALLOWED A PARTIAL ABSENCE FOR ANOTHER ACTIVITY.

\_\_\_c. YOU WILL BE REQUIRED TO GIVE THE TTDC JUST AS MUCH COMMITMENT AS YOU DO YOUR SCHOOL TEAM AND APPLY YOURSELF TO THE FULLEST DURING ALL PRACTICES AND EVENTS. THOSE MAKING THE CHOICE TO PARTICIPATE IN ANOTHER TEAM MUST REALIZE THAT SACRIFICES WILL HAVE TO BE MADE, AND TRIPLE THREAT CANNOT BE EXPECTED TO GIVE CONTINUOUS ADJUSTMENTS. IF YOU ARE AWARE YOU WILL BE MISSING MULTIPLE PRACTICES FOR OTHER TEAM EVENTS, THEN YOU WILL NEED TO LIMIT THE AMOUNT OF ABSENCES YOU HAVE FOR OTHER UNNECESSARY REASONS.

\_\_\_c. REPRESENTATION OF THE TRIPLE THREAT COMPANY WHILE AT COMPETITIONS OR OTHER PERFORMANCES ALSO EXTENDS TO THE PARENTS OF OUR DANCERS. PLEASE ABIDE BY THE RULES SET FORTH BY OUR TRIPLE THREAT STAFF AND AID US IN UPHOLDING THE SAME RULES WITH YOUR CHILDREN.
